WINSTON TRAILS EAST COMMUNITY DEVELOPMENT DISTRICT PUBLIC HEARING & REGULAR BOARD MEETING JUNE 12, 2023

A. CALL TO ORDER

District Manager Jason Pierman called the June 12, 2023, Regular Board Meeting of the Winston Trails East Community Development District (the "District") to order at 6:37 p.m. in the Recreation Center located at 5980 Winston Trails Boulevard, Lake Worth, Florida 33463.
